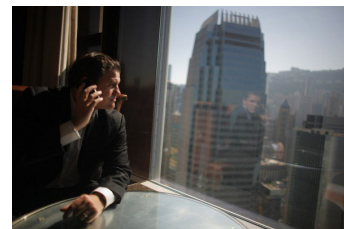
So now the real question is: How much longer will law students continue to stick with the major bar review companies that can't seem to get them to pass?

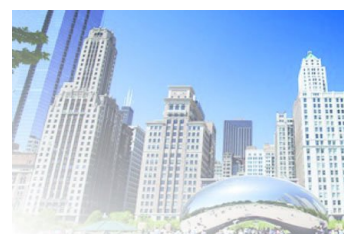
