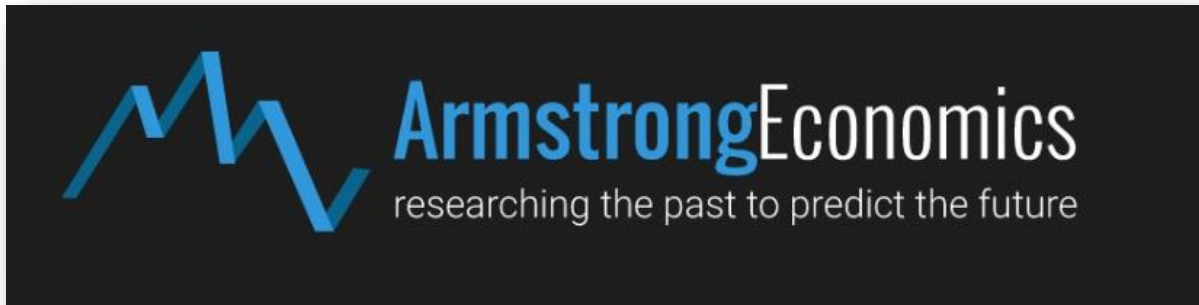

and here they are taking money on the side from Gates. In return for that money, he has been controlling the direction of healthcare without being a doctor.

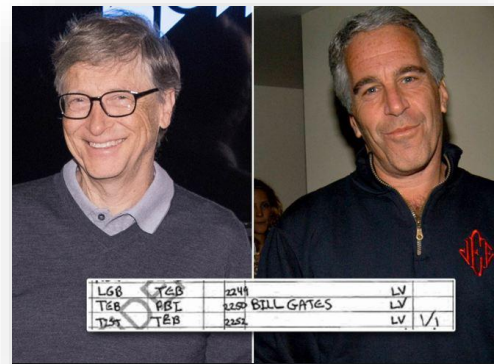

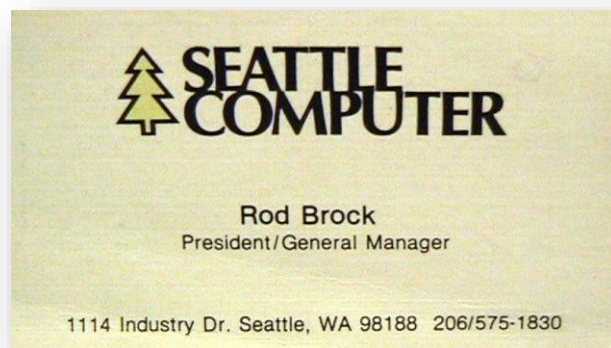


Gary Arlen Kildall
(1942 - 1994)

It is well known in among programmers that Bill Gates didn't write the operating system which made Microsoft known as DOS. Gary Kildall (1942-1994) wrote CP/M, an operating system that ran on early microcomputers based on 8-bits. IBM either couldn't or wouldn't make a deal with Kildall. Bill Gates bought what became MS DOS from **Seattle Computer Products** for \$50,000 and licensed it to IBM.

DOS was actually written by a 22-year old Tim Paterson (born June 1, 1956). How much of Kildall's intellectual property he appropriated is a matter of some dispute. IBM later did make a deal with Kildall by some accounts after threatening to sue

IBM because DOS infringed on his copyright. The early IBM PC was sold with both CP/M and DOS operating systems, but CP/M was sold at a much higher price. Many never were aware of the two systems. Most buyers simply chose MS DOS, which became the standard, or were steered toward MS DOS by IBM.



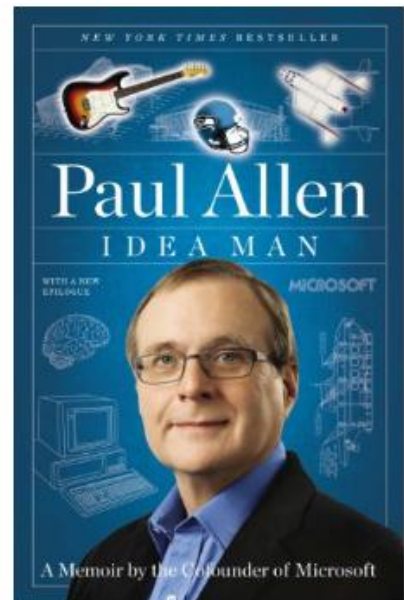

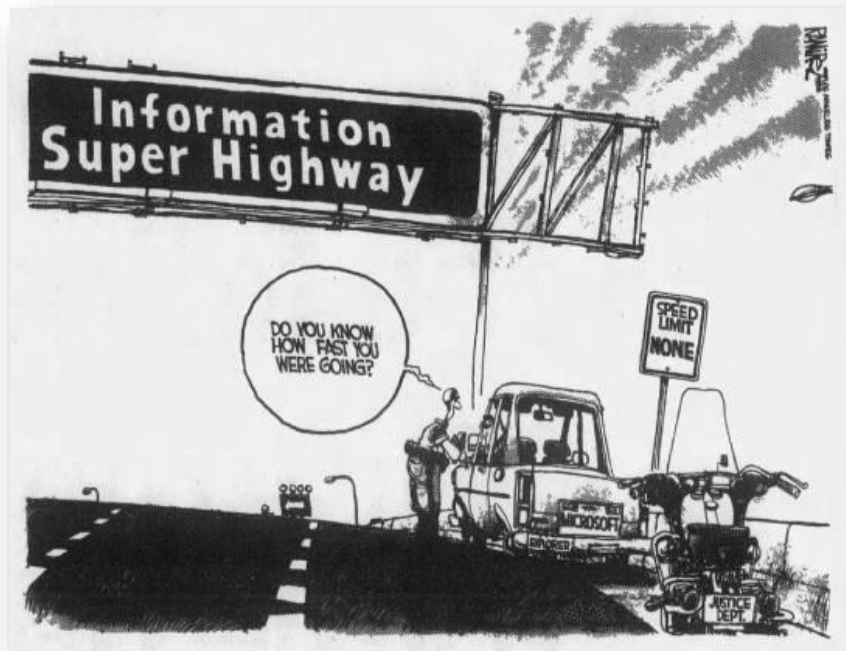
Gate's reputation has always been cloudy. His co-founder of Microsoft, Paul Allen (1953–2018), wrote in his memoirs that Bill Gates is a ruthless schemer who demeaned his employees and conspired to rip off his business partner.

Mr. Gates and Mr. Allen first became friends in 1968 over their Seattle high school Teletype machine, on which they wrote their first software together. Mr. Allen moved to Boston and Gates dropped out of Harvard University in 1975 so they could work on what would eventually become Microsoft.

The authors of "Primal Leadership" wrote in the Harvard Business Review some years ago that Gates was one of "those infamous corporate leaders who seem to have achieved sterling business results despite their brutish approaches to leadership." Allen referred to his former partner as a "taskmaster" who would "prowl" the parking lot on weekends to document who had arrived at work.

Microsoft founder Bill Gates stepped down in February 2000 as chief executive of Microsoft allegedly as part of the settlement with the Department of Justice in his battle in violation of the Sherman Anti-Trust Act. Gates remained as Chairman of Microsoft with the new title of Chief Software Architect. He then claimed he wanted to return "to what I love most, focusing on technologies for the future." This was an interesting explanation but far from voluntary.

What led to this was, on May 18th, 1998, the Department of Justice (DoJ) and the attorneys general of 20 different states filed antitrust charges against Microsoft to determine whether the company's bundling of additional programs into its operating system constituted monopolistic actions. The suit was brought following the browser wars that led to the collapse of Microsoft's top competitor, Netscape, which occurred when Microsoft began giving away its browser software for free.

Charges were brought against Microsoft to determine whether its bundling of additional programs into its operating system constituted monopolistic actions. Back then, there were rising concerns that it was impossible to compete against Microsoft and many alleged Gates was a ruthless businessman. The government case accused Microsoft of making it difficult for consumers to install competing software on computers operated by Windows.



Gates was accused of creative editing of video, twisting facts, and emails, but Microsoft still lost the case. The presiding judge, Thomas Penfield Jackson, ruled that Microsoft violated parts of the Sherman Antitrust Act, which was established in 1890 to outlaw monopolies and cartels. He found that Microsoft's position in the marketplace constituted a monopoly that threatened not only the competition but also innovation in the industry. You could not invent a product for Microsoft would create a competitive and put you out of business.

Judge Thomas Penfield Jackson used an anecdote about a man who used a two-by-four in training a mule to do remarkable tricks. He said in the trial, "I hope I've got Microsoft's attention," quoted from *US v Microsoft* by Joel Brinkley and Steve Lohr. The government discredited all of Microsoft's witnesses and the judge simply commented that he found them unbelievable.

'Robber barons'

Riled Reno wants more competition

Using the harshest language yet regarding the high-stakes Microsoft anti-trust case, Attorney General Janet Reno said there must be greater competition so there will be alternatives to "robber barons."

But Reno did not deny that the Justice Department still buys tens of thousands of personal computers that run Microsoft's Windows, rather than trying to encourage competition by purchasing PCs with alternative operating systems.

"I don't think that you endorse something by purchasing it, if that's the only game in town ... in terms of an effective machine, low price, the lowest price available," she said.

Reno also said the agency buys "the best equipment possible at the lowest price possible to benefit the American taxpayers. We think we can do that more effectively if we have great-

er competition."

Thomas Penfield Jackson, the judge in the Microsoft anti-trust case, ruled in April that the company used its monopoly power to keep competitors at bay by exploiting the popularity of Windows to crush Internet rivals.

The Justice Department has asked the judge to split the company in two to help create competition in the marketplace, and he is expected to rule next week on a remedy.

"The whole thrust of the anti-trust effort is to create competition, good competition, vigorous competition," Reno explained at a weekly news confer-

ence.

"America was not made the industrial giant of the world by the robber barons alone. It was made the industrial giant of the world by competition, by encouraging new developments, by encouraging young entrepreneurs to break into the market," she added.

"It's the best system I've seen so far."

Although reporters had been asking the attorney general about the Microsoft case, a spokeswoman later emphasized that Reno's comments were not about a specific case.

"The attorney general made clear that she declined to discuss the Microsoft case because it was pending before the court," the spokeswoman said. "The comments she made were directed at general issues of anti-trust policy, not on a specific case."

Bill Gates was being viewed as a ruthless robber baron. One critical example of how Microsoft was restricting programmers. Sun Microsystems developed the programming language Java that would run on any operating system. Microsoft developed its own Java that would only run on Microsoft operating systems. This was the very core of how Bill Gates would engage in monopoly practices and this is what he has been doing in the healthcare industry buying into every vaccine

and donating to every government agency from the FDA, CDC, NIH, WHO, you name it, Gates has funded it not just in the United States but in Britain and Europe.

Judge Jackson also called for Microsoft to divide the company in half and create two separate entities that would be called baby Bills. The operating system (MS DOS/Windows) would make up one half of the company and the software arm would make up the other.

Microsoft appealed citing the Judge was biased in favor of the prosecution. The appeals court overturned Judge Jackson's decision against Microsoft which seemed as if that too was rigged. Instead of seeking to break up the company, the Department of Justice decided to settle with Microsoft. In its settlement, the DoJ abandoned the requirement to break up the company, in return, Microsoft agreed to share computing interfaces with other companies.

Microsoft saw its once invincible market share erode due to old-fashioned competition at last which allowed computers to finally explode after Gates' control was demolished. This is what has been alleged was part of the unpublished deal that Gates himself would step down, which he interestingly allegedly did to avoid the breakup of Microsoft. Make no mistake about it, what Gates was doing was in fact preventing computer innovations by preventing other companies from competing thereby confining all innovation to exclusively Bill Gates.

Bill Gates' father was the head of **Planned Parenthood**. Many saw this as a covert means to justify abortion among minorities to reduce the population which he has been so concerned with which is why he has supported the Climate Change movement. Bill Gates in an interview said:

Many know of the racist legacy of Margaret Sanger (1879–1966), the founder of Planned Parenthood, who once gave a talk to the KKK and helped promote the “Negro Project.” In her own words, “[Birth control] means the release and cultivation of the better racial elements in our society, and the gradual suppression, elimination and eventual extirpation of defective stocks—those human weeds which threaten the

blooming of the finest flowers of American civilization.” (NYT, April 8, 1923). To this day, 79% of Planned Parenthood's surgical abortion facilities are located within walking distance of African American or Hispanic/Latino neighborhoods (Map).

Few know that this project is continued on an international scale by the enormous wealth of Bill Gates. In 1965, the Rockefeller Foundation was alleged to be a significant donor to the **International Planned Parenthood Federation (IPPF)**. Today, the Bill and Melinda Gates Foundation has spent billions on population control in Africa and throughout the Third World. They too have donated to IPPF.¹ Obianuju Ekeocha, author of *Target Africa*, wrote in her 2012 open letter to Melinda Gates:

“Amidst all our African afflictions and difficulties, amidst all the socioeconomic and political instabilities, our babies are always a firm symbol of hope, a promise of life, a reason to strive for the legacy of a bright future. So a few weeks ago I stumbled upon the plan and promise of Melinda Gates to implant the seeds of her ‘legacy’ in 69 of the poorest countries in the world (most of which are in Sub-Saharan Africa). Her pledge is to collect pledges for almost \$5 billion in order to ensure that the African woman is less fertile, less encumbered and, yes, she says, more ‘liberated.’”

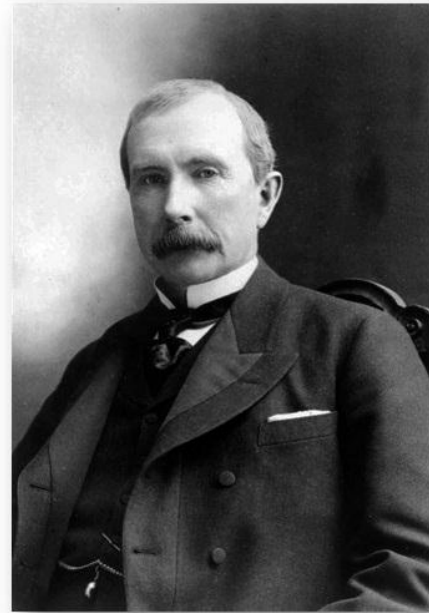

John Davison Rockefeller Sr. (1839–1937) was born into a large, poor family in upstate New York that moved to Cleveland, Ohio. He became an assistant bookkeeper at age 16 and went into several business partnerships beginning at age 20, concentrating his business on oil refining. He became rich when he founded the Standard Oil Company in 1870. He ran it until 1897 and remained its largest shareholder.

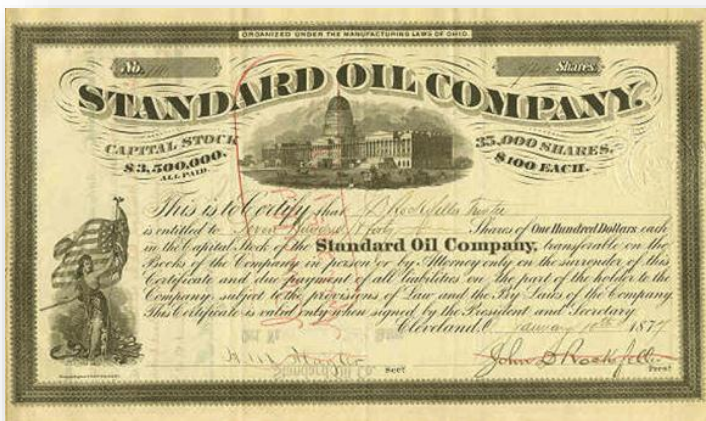
After Rockefeller retired, he spent most of the last 40 years of his life creating modern philanthropy. His fortune was mainly used to create targeted philanthropy, which has been the model for Bill Gates. Rockefeller created foundations that targeted medicine, education, and scientific research. His foundations funded medical research and nearly eradicated hookworm and yellow fever that killed many in Philadelphia during the mid-19th century.

By 1865, Standard Oil was the largest and most profitable organization in the world, moving to Manhattan to house all the new employees. At last in 1911, the Supreme Court of the United States found Standard Oil Company of New Jersey in violation of the Sherman Antitrust Act. It was to be broken up. Standard Oil was eventually forced to break into multiple companies because it was ruled a monopoly, BP,

Exxon, ConocoPhillips, and Chevron (among others) are all subsidiaries of Standard Oil. Curiously, Rockefeller has been Bill Gates' idol. Microsoft was also to be broken up, but Gates stepped down as part of the deal.

Rockefeller is usually portrayed as a villain with a host of bad traits. He was ruthless, unscrupulous, greedy, and a noted bully who carved a very cruel path to dominance. As a percentage of the United States' GDP, no other American fortune ever reached such a height 1.6% of a GDP, which was \$92 billion when he died. Bill Gates may be following Rockefeller and his philanthropy returns a profit like his shares in vaccines. He pretends to hand out money when in fact it is more like venture capitalism. But today, GDP is about \$21 trillion so to match Rockefeller, Bill has to accumulate \$336 billion. According to Forbes, Bill is worth \$130.6 billion, so he has to create a lot more diseases to manufacture endless vaccines to catch up at just 0.006%.

The New York Times reported on Rockefeller in 1937: *"He was accused of crushing out competition, getting rich on rebates from railroads, bribing men to spy on competing companies, of making secret agreements, of coercing rivals to join the Standard Oil Company under threat of being forced out of business, building up enormous fortunes on the ruins of other men, and so on."*

Likewise, Bill Gates is leaving his children a tiny fraction of his wealth, again, following Rockefeller. Yet, the curious connection runs even deeper.

Bill Gates' father is William H. Gates Sr., a Co-Founder of Preston Gates & Ellis (they had offices across the United States and China). A prominent banker and lawyer, William H. Gates Sr. was also deeply involved with politics and "philanthropy". In the era before Roe v. Wade, he sat on the board of Margret Sanger's Planned Parenthood.



Frederick Taylor Gates managed Rockefeller's charitable activities and was instrumental in the founding of the philanthropic Rockefeller Foundation, serving on its board of trustees until 1923, according to The Rockefeller Archive Center. But he is not related to Bill Gates in any way. Perhaps this conspiracy theory was put out then to defuse the real connections.

The Gates and Rockefellers are old friends and partners in the **Global Alliance for**

Vaccines and Immunization (GAVI). The alliance, which controls major international vaccine programs, has the following as members: The Bill and Melinda Gates Foundation, the Rockefeller Foundation, the International Federation of Pharmaceutical Manufacturers Associations, UNICEF, World Bank, WHO, and many national governments.

British Prime Minister Boris Johnson's father, Stanley Johnson, is none other than from the same club as Bill Gates' father and a eugenicist. Stanley changed his job to work for the Rockefeller Foundation in New York. All his ideas are that of Gates and Rockefeller, and he justifies cheering a reduction of 70 million people from the population in Britain to 10 million to enhance economic growth. He also put out a book called the VIRUS which is



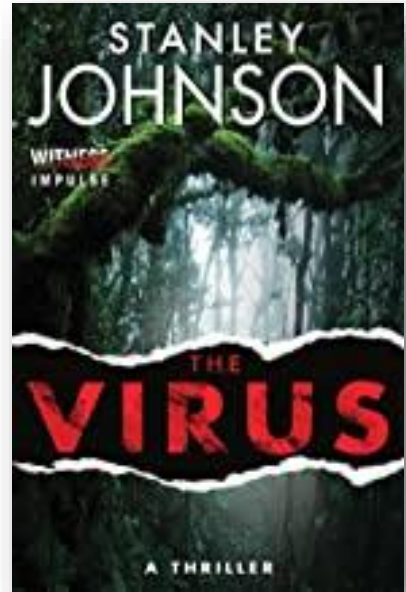
about a young woman in New York City who dies mysteriously after a trip to Europe. Top epidemiologist Lowell Kaplan then identifies the cause of death as the Marburg Virus, which is a fatal strain that has surfaced only once before in history.

Marburg virus disease (MVD) is a rare but severe hemorrhagic fever which affects both people and non-human

primates. The six species of Ebola virus are the only other known members of the filovirus family.

Marburg virus was first recognized in 1967, when outbreaks of hemorrhagic fever occurred simultaneously in laboratories in Marburg and Frankfurt, Germany and in Belgrade, Yugoslavia (now Serbia). The infected people caught the disease from importing Ugandan African green monkeys.

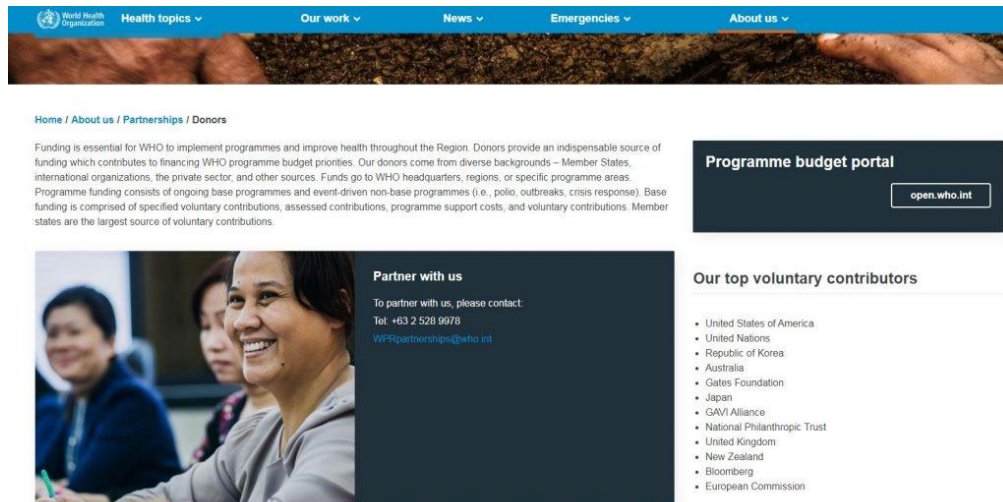
Why people have been curious about this book is because the reservoir host of Marburg virus is the African fruit bat, *Rousettus aegyptiacus*. Fruit bats infected with Marburg virus do not show obvious signs of illness. Primates (including people) can

This entire movement which has been spearhead by Bill Gates while he had three children smacks of Eugenics which is the same program of Adolf Hitler – to weed out the undesirable races.

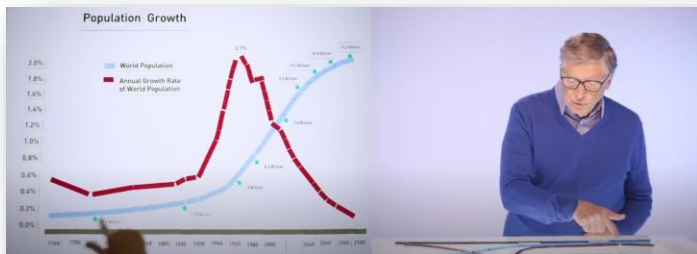

Most infectious-disease studies pose modest safety risks, but given that these proposed experiments intended to create a highly contagious flu virus that could spread among humans, the government concluded the work should not go on until it could be approved through a specially created, rigorous review process that considered the dangers.

Apparently, the government has decided the research should now move ahead. In the past year, the U.S. government quietly greenlighted funding for two groups of researchers, one in the United States and the other in the Netherlands, to conduct transmission-enhancing experiments on the bird flu virus as they were originally proposed before the moratorium. Amazingly, despite the potential public-health consequences of such work, neither the approval nor the deliberations or judgments that supported it were announced publicly. The government confirmed them only when a reporter learned about them through non-official channels.

This lack of transparency is unacceptable. Making decisions to approve potentially dangerous research in secret betrays the government's responsibility to inform and involve the public when approving endeavors, whether scientific or otherwise, that could put health and lives at risk.⁵

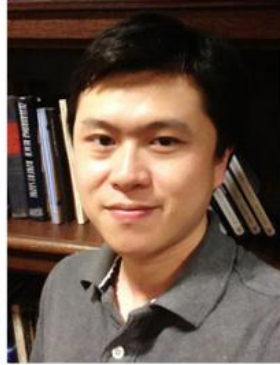

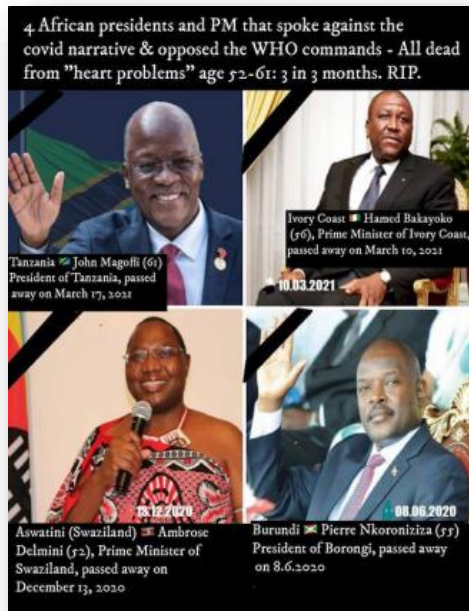

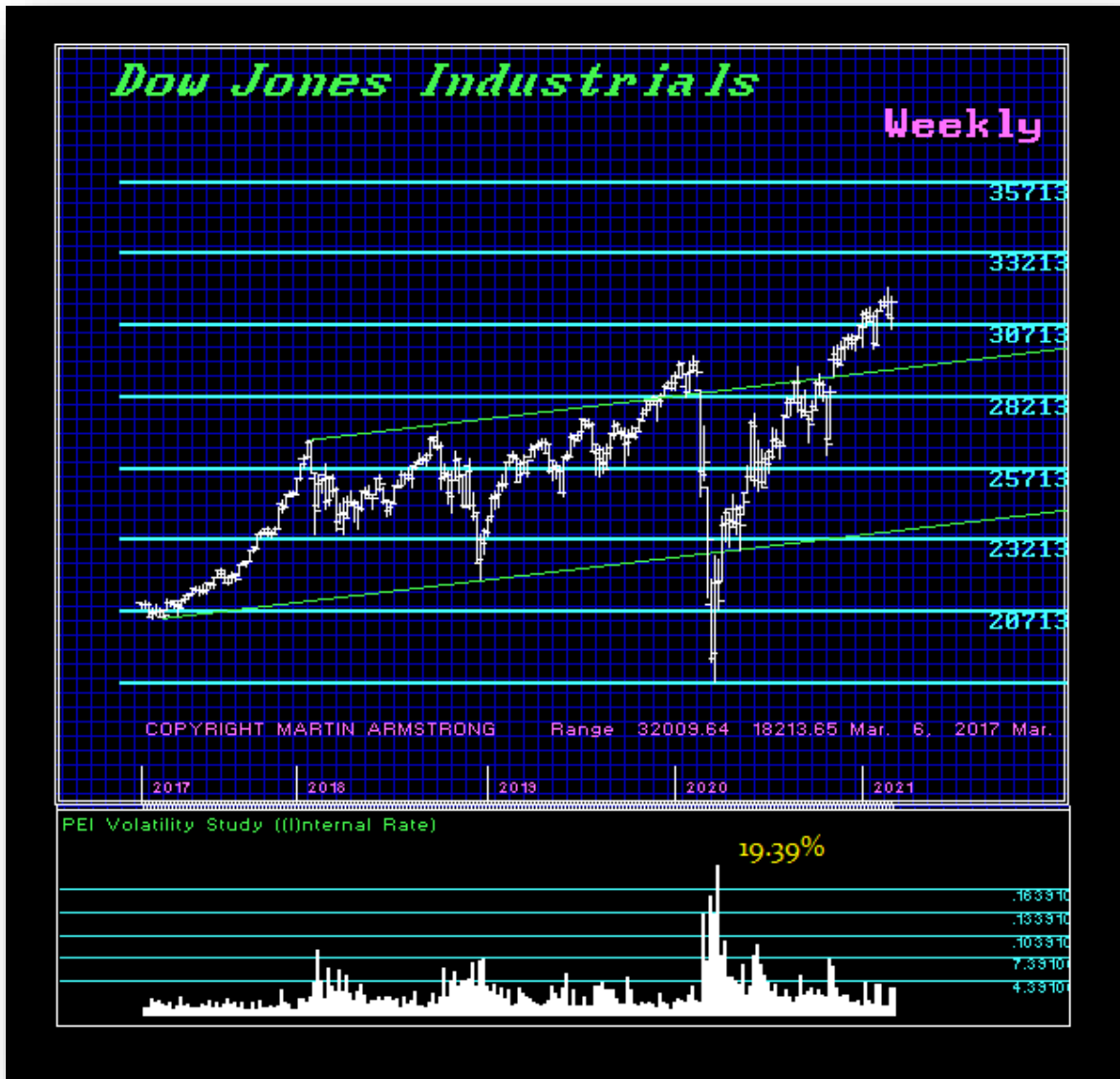


BUILD BACK BETTER

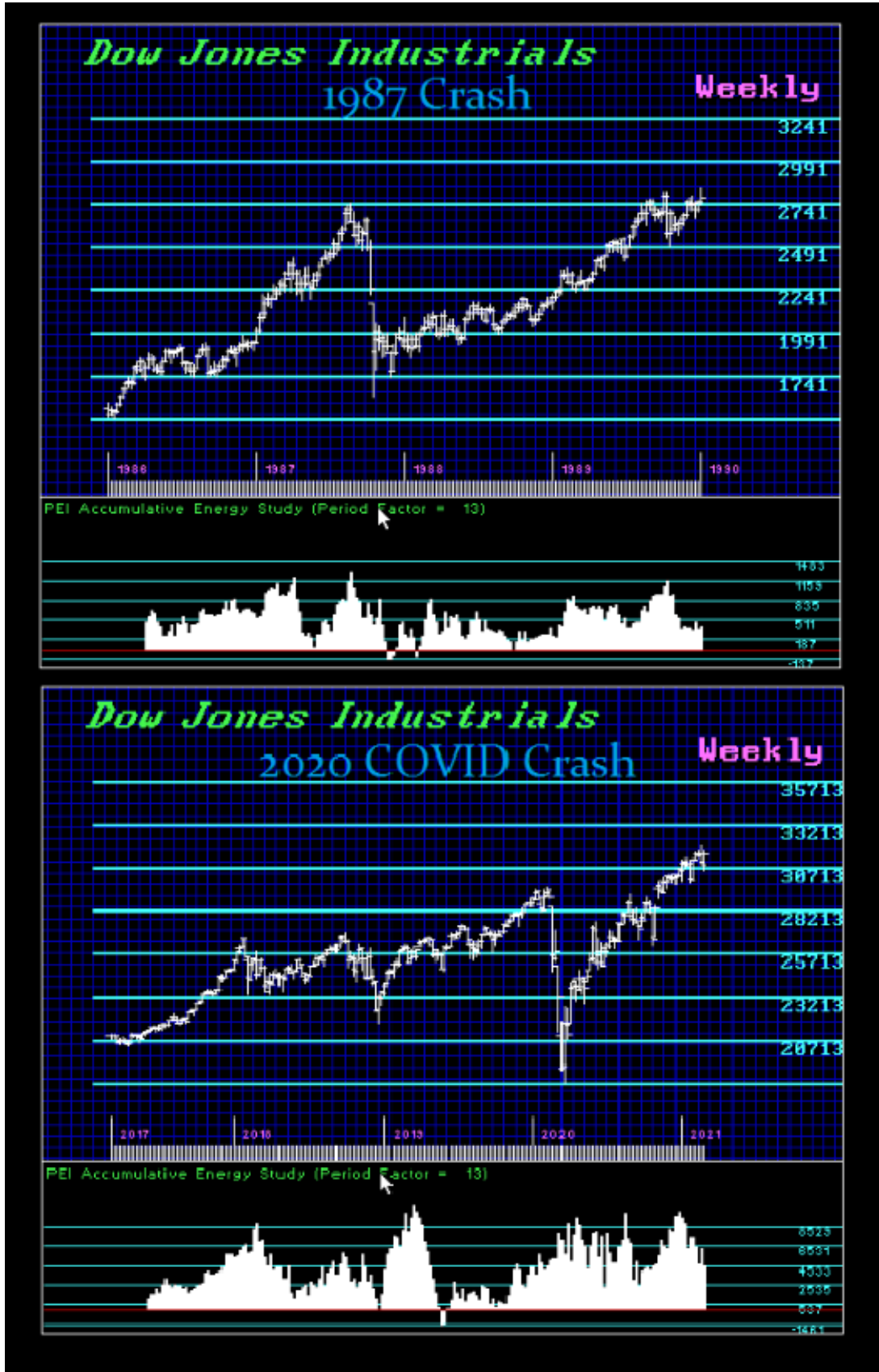

WEF, he has a zero-error policy. For whatever reason, Schwab controls the agenda. Coincidences do not exist at this level in the game.

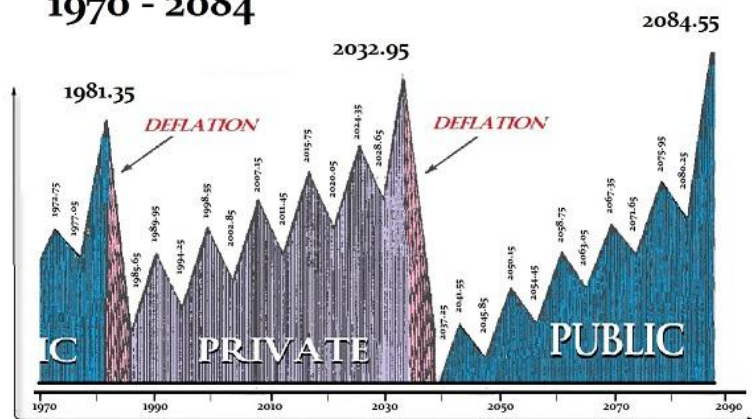
Was AIDs Created in a Lab?



The peak of the Economic Confidence Model (1981.35) also marked the beginning of a major pandemic when the first cases were reported in 1981 of acquired immunodeficiency syndrome (AIDS) virus. The infection with human immunodeficiency virus (HIV) grew to pandemic proportions, which resulted in an estimated 65 million infections and 25 million deaths. But this required sexual contact or a blood transfusion with infected blood. Coronaviruses, such as the common cold, spread via droplets when a person coughs or sneezes. It can also spread when someone touches a contaminated surface, such as a door handle. This is significantly different from the AIDS pandemic.

1970 - 2084



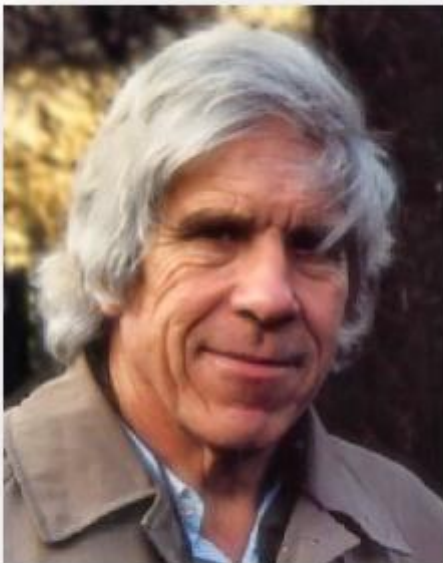

Was AIDS Created in a Lab?

There has been a long-standing view that Dr. Anthony Fauci was very cavalier also with AIDS, and the drugs he rushed through approval also killed people and cured nobody. He is doing the very same thing with COVID rushing experimental vaccines that have killed many people. Dr. Anthony Fauci had written on AIDS back in 1983. Fauci wrote in 1983:

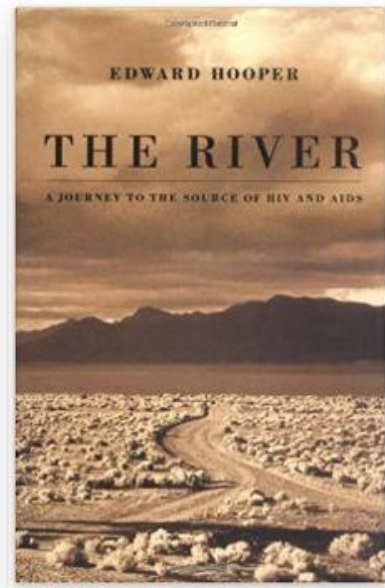
Hamilton's ideas were rejected, and some tried to portray him as a nut or conspiracy theorist. Hamilton even gave supportive declarations on this argument, which was published in the BBC. In truth, those in power had to deny any such allegation because it would make those in power appear to be the culprits and this was a disease killing countless people around the world.

This is the way the system operates. There are no mirrors in government for them to ever to look upon themselves as the source of a crisis. They must always hunt someone down from the private sector with no government funding.

Hamilton later wrote the foreword of a 1999 book, **"The River,"** by journalist Edward Hooper (born 1951), who investigated this theory. Most people have no idea that a monkey virus SV40 was found in the polio vaccine. The discovery of SV40 revealed that between 1955 and 1963 around 90% of children and 60% of adults in the United States had been inoculated with SV40-contaminated polio vaccines. For four decades, government officials have insisted that there is **no evidence** the Simian Virus (called SV40) was harmful to humans, which of course was a lie.

In April 1955, more than 200,000 American children in five Western and mid-Western states received a polio vaccine in which the process of inactivating the live virus proved to be defective. Within days there were reports of paralysis, and within a month, the first mass vaccination program against polio was abandoned. The children were, of course, collateral damage as people suffering from the COVID vaccines are once again being treated.

The polio case, in addition, triggered litigation that set the pattern for future medical lawsuits, which continue to frustrate innovation today, Offit said. He writes about the Cutter case in the current issue of the *New England Journal of Medicine*.

Tomorrow scientists will mark the 50th anniversary of the announcement that the polio vaccine developed by Jonas Salk of the University of Pittsburgh had proven successful in a study involving 1.8 million children, and that routine vaccination of the nation's children could begin.

"It's one of the great American stories of science and technology," said Howard Markel, a physician and medical historian at the University of Michigan, where 1,200 people jammed into an auditorium to hear the results.

A nation gripped by fear embraced news that Salk's vaccine, made of killed polio virus, was "safe, effective and potent," according to the epidemiologist quoted at the original news conference.

There were well-ingrained images in the public's mind of healthy, happy children playing one minute, and then paralyzed and in an iron lung the next.

"You could put your child to bed at night, and the child might complain of a sore throat, nothing much, and the next morning the child might say, 'Mommy, Daddy, I can't move my legs,'" Markel said.

Mary Jane Newman, 81, of Newtown Square, Delaware County, was raising two boys in Pittsburgh in the early 1950s and polio was one of her biggest worries.

"We never let our kids go to the movies or swimming or anything" for fear of being exposed to the virus, Newman recalled last week. When a letter came home from school saying her boys could get the experimental Salk vaccine, "we were so afraid of polio, we decided we should let our children help out," she said.

But Offit offers a surprising look at how joy over the new vaccine was quickly tempered. Within two weeks of the vaccine's rollout, the government got word that five children in California had become paralyzed after getting vaccine made by Cutter Laboratories.

Cutter vaccine was recalled, but not before 380,000 of the company's doses had been administered. An investigation traced the problem to two lots of vaccine, 120,000 doses in all, which contained live polio virus, Offit said. Formaldehyde used in the production process should have killed the virus, but didn't.

The nation's polio-immunization campaign was halted for about a week while the investigation was being done, but then quickly resumed. Today such a scandal would likely cause a vaccine's withdrawal and a company's demise, Offit said, but attitudes were different in the 1950s.

"People were scared to death of polio and the fact was that, for the most part, there was faith in the polio program," Offit said.

He said the Cutter incident led to new federal regulations for vaccine production.

Offit said the Cutter incident also helped set the stage for the often contentious medical-legal climate that exists today.

A lawsuit filed by a family whose child was harmed by the vaccine resulted in a new type of verdict in which Cutter was found liable, or financially responsible, for problems caused by its product. But it was not found negligent in the production of the product — resulting in the legal precedent of "liability without fault," Offit said.

"Since proof of negligence was no longer required, it was easier for juries to find pharmaceutical companies liable," he wrote.

Offit contends that fears of being sued have "driven companies away from making life-saving products like vaccines."

Offit said his interest in writing about the Cutter incident was sparked by conversations over lunch with Neal Nathanson, a University of Pennsylvania virology specialist who 50 years ago was a public health doctor assigned to investigate polio cases associated with the vaccine.

Nathanson, in an interview, said he had just arrived at what is now called the Centers for Disease Control and Prevention (CDC), when he was appointed to head the new Polio Surveillance Unit.

"I was the only body that was free," he recalled. "I had no training at all ... It was truly an on-the-job kind of thing."

The government's investigation revealed that Cutter wasn't the only manufacturer with problems. Wyeth Laboratories, for one, also produced some faulty vaccine that was linked to at least 15 cases of paralysis and one death, Offit said.

Nathanson, as part of his job, produced a report specifically on Wyeth.

But the report was never made public — a decision he said was made by his superiors.

All the companies quickly made improvements in manufacturing. The Cutter incident faded from the public's mind and confidence in the polio immunization program was restored.

"Between 1955 and 1962, a total of 400 million doses of safe, inactivated polio vaccine were distributed in the United States," Offit wrote in the April 7 *New England Journal of Medicine*. "The incidence of polio decreased dramatically."

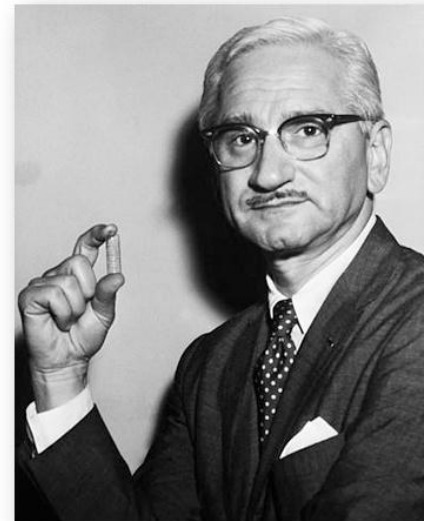

Back then, there were two scientific experts, Dr. Hilary Koprowski (1916–2013), who was the director of the Wistar Institute in Philadelphia, and Dr. Albert Sabin (1906–1993), who was a physician at the Cincinnati Children's Hospital. The two began a race to replace the Salk vaccine. Dr. Cecil Fox, a pathologist at the National Institute of Infectious Diseases remembers that it was an intense competition. Interestingly, both Sabin and Koprowski's vaccines were derived from monkey organs. They needed to test them in large, non-immunized population groups, no longer available in North America.

Consequently, Sabin traveled to the U.S.S.R. and vaccinated more than 6 million people in Latvia, Estonia, and Kazakhstan between 1958 and 1959. There were NO AIDS cases that emerged in the U.S.S.R. where Sabin did his testing. However, Koprowski went to the Belgian Congo to conduct his study. This is where one of Africa's more modern health care infrastructures existed at that time. Between 1956 and 1960, Koprowski injected more than 1 million Africans with his version of a vaccine called CHAT.

AIDS emerged in Africa most likely from this test group. Sabin analyzed Koprowski's vaccine in 1958 and found it to be 'unstable and contaminated by an unknown virus.' When we turn to Australia, we see the very same agenda to exploit COVID for political purposes. What ever took place under the flu (influenza) has now been attributed to COVID.

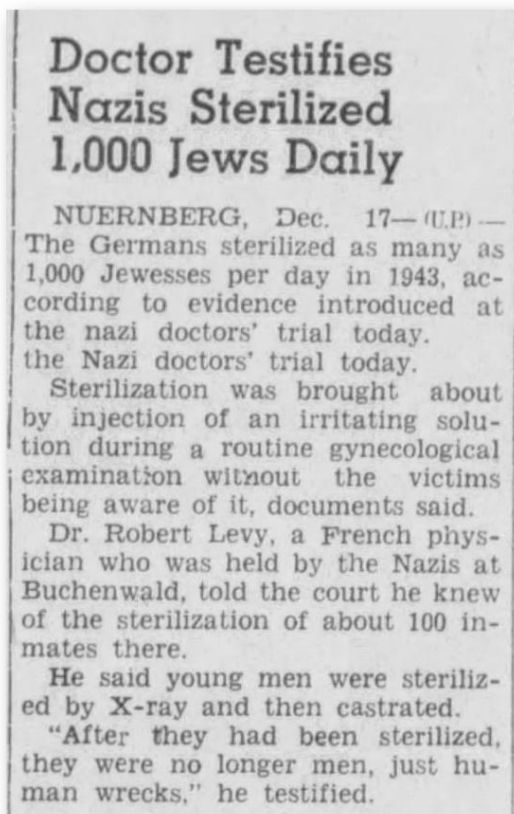

entire fabric of society collapses into chaos.

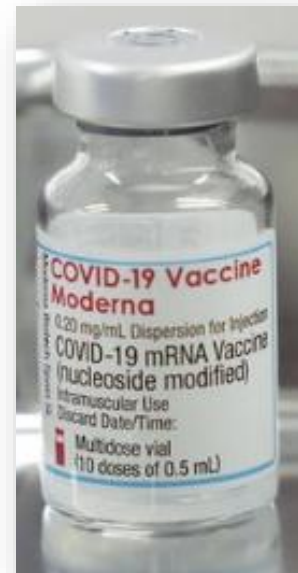

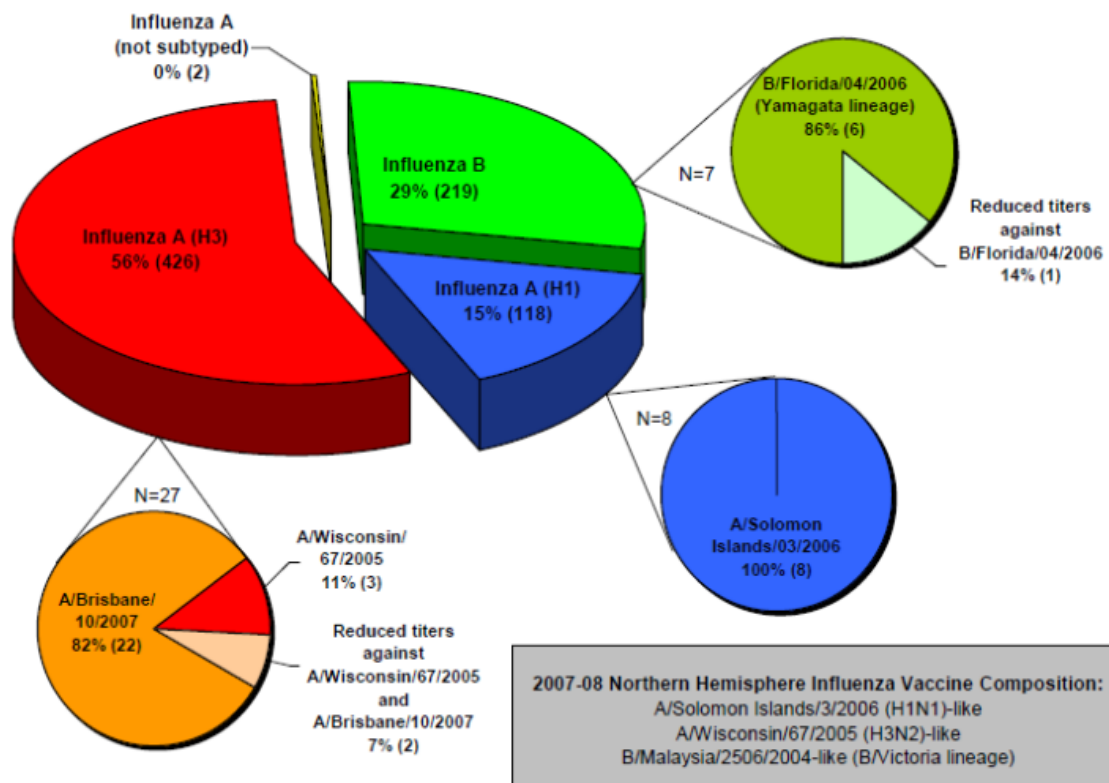

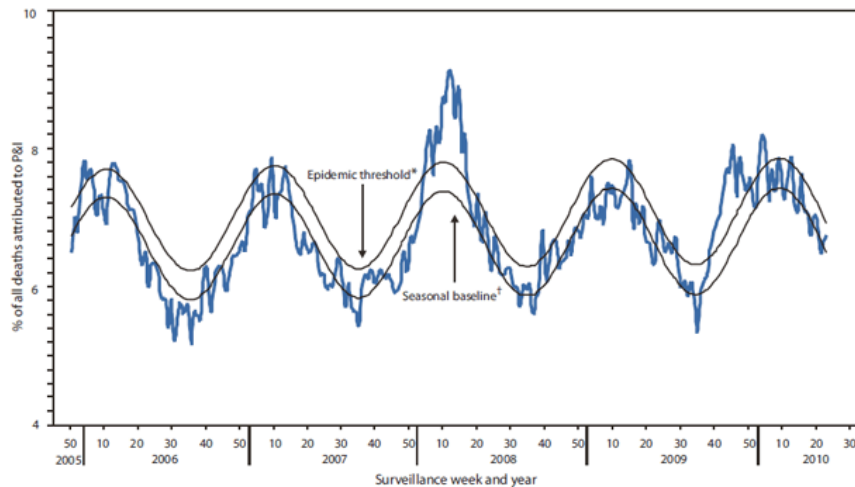

* The epidemic threshold is 1.645 standard deviations above the seasonal baseline.

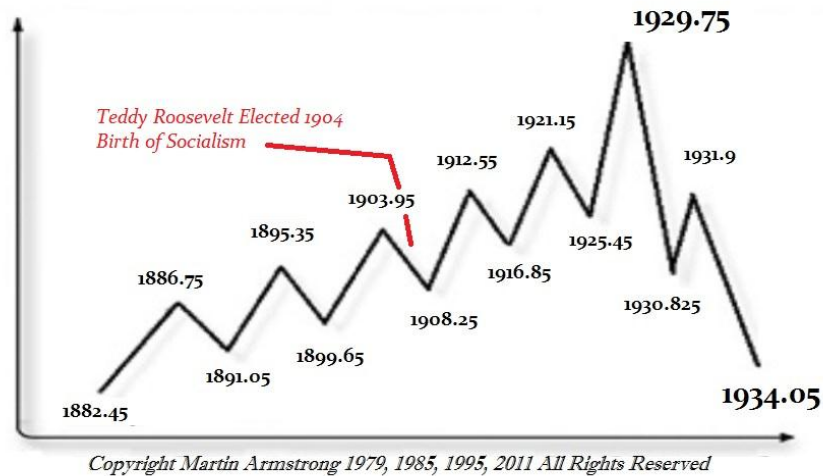
We can see that each flu season is different. Some impact more than others simply because of the mix of viruses unfolding during that season. Unfortunately, when we look into 2022, this is where the disease cycle begins to turn up more aggressively. This will be 190 years from the **Great 1832 Cholera PANIC** that killed countless thousands of people around the world. Even 190 years before that was 1642 where the English Civil War is believed to have resulted in 180,000 deaths but only 80,000 on the battlefield. 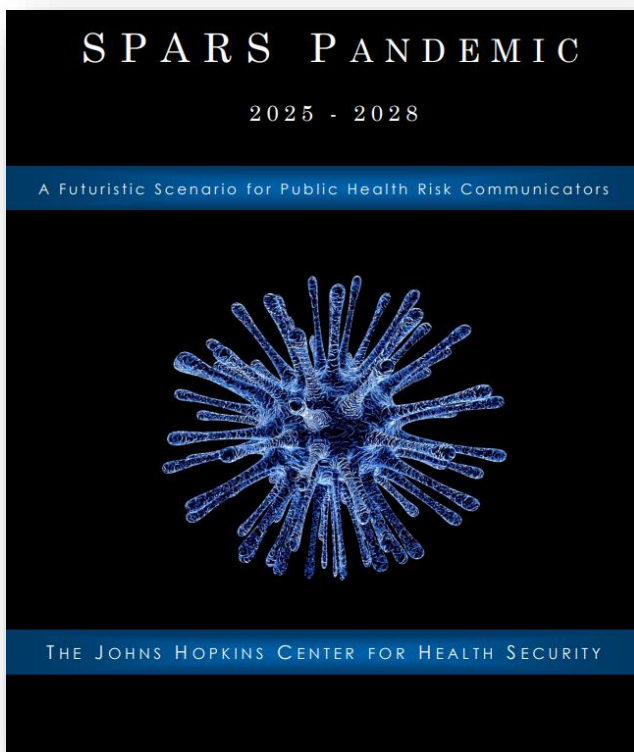
The **Black Death** created a very dynamic economic impact by increasing individual wealth, reducing the population creating a shortage of labor, and price inflation. This was the free markets at their best.

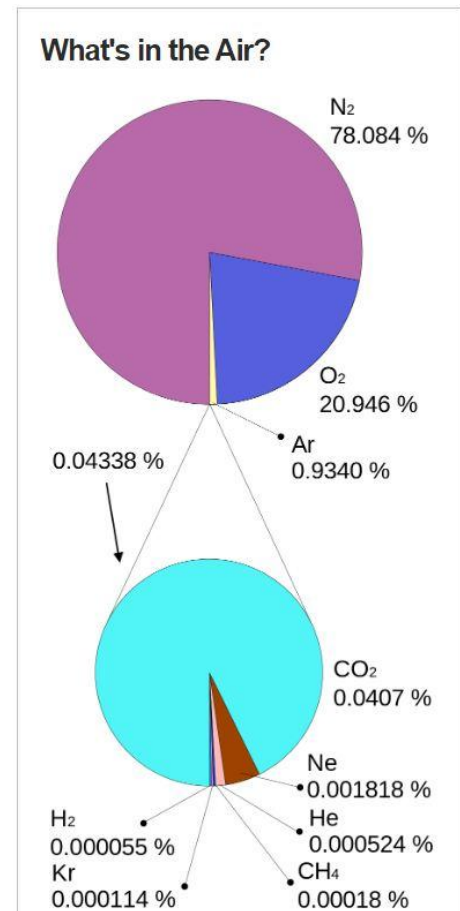

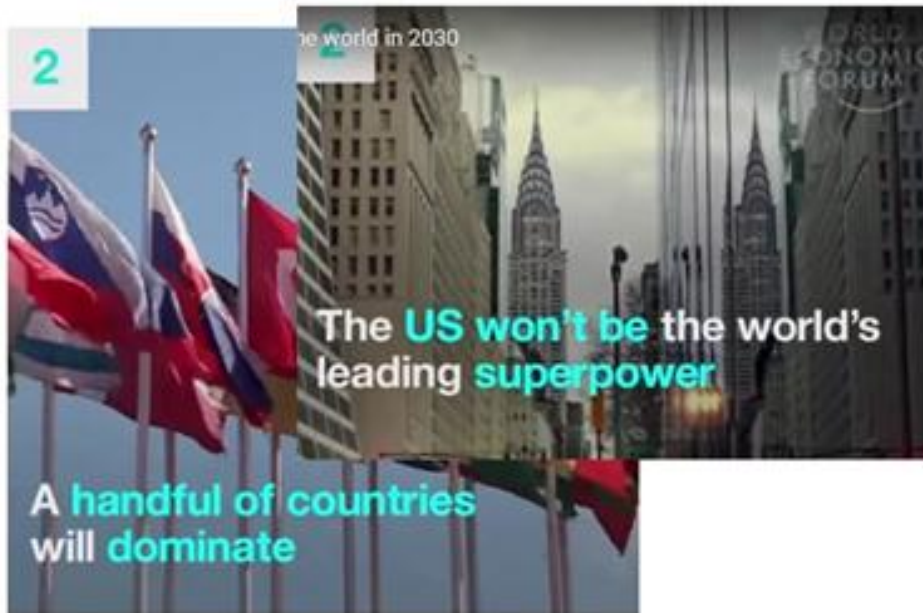

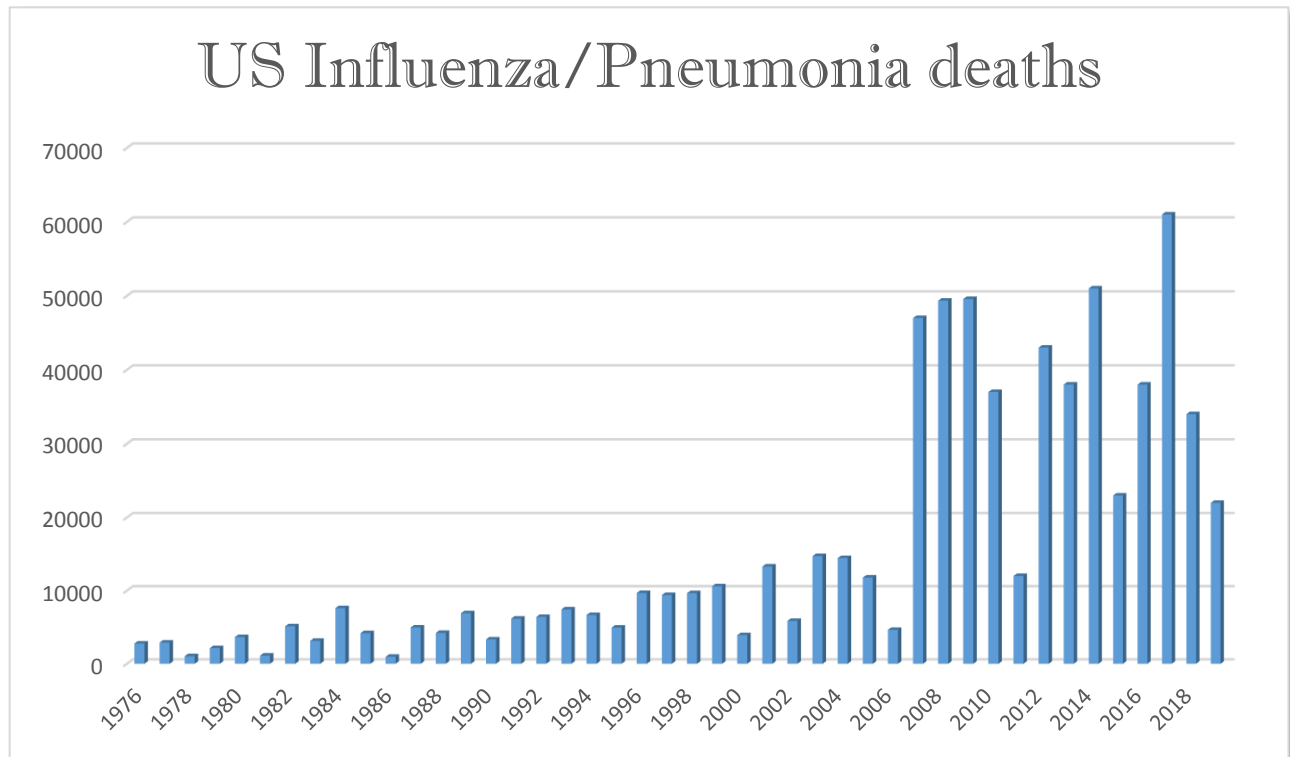
